GOING VIRTUAL

Immunize Oregon and the Oregon HPV Prevention Alliance are excited to convene providers, stakeholders, and content experts from across the region to host virtual events and meetings. Curriculum and agenda topics are designed to bring together public health professionals, healthcare personnel, epidemiologists, researchers, policy advocates, clinic managers, students, community members, and anyone seeking comprehensive knowledge of immunizations. The coalition will pursue continuing education credits each session but cannot guarantee each virtual event and meeting will provide credit opportunities.

The virtual community platform aims to host expert speaker sessions throughout the year. To provide opportunities for member engagement during discussions, speaker presentations will be held on various dates and times to accommodate the busy schedules of health professionals. Virtually access allows more individuals to participate and provides a space to strengthen partnerships with influential leaders while gaining professional education and training from expert speakers. Immunize Oregon and the Oregon HPV Prevention Alliance aim to highlight the importance of vaccination by showcasing the latest trends supporting best practices and engaging health professionals in initiatives promoting community immunity. Immunize Oregon offers a wide variety of education. Registration fees & payment, financial supporters, and exhibits may not apply to some educational events.

IMMUNIZE OREGON

Immunize Oregon is a network of community members, health professionals, and partner agencies with a common goal of preventing disease and improving the quality of life for all Oregonians. Partnership is key to prevention and our coalition represents a variety of immunization stakeholders statewide, including parents, grandparents, religious leaders, nurses, physicians, pharmacists, public health professionals, direct service providers, researchers, and clinical educators. We work to address local priorities by including partners across the state to improve health for everyone. Our role is to support and advise health professionals, policymakers, and the community on the current science and clinical best practices regarding immunizations.

CODE OF CONDUCT

The coalition virtual community will bring together professionals of various disciplines from around the region. The content will focus on evidence-based immunization topics and sharing of best practices. We will encourage networking, and discussion, and will provide specific agenda time for questions. Interruptions, impoliteness, or disruptive behavior will result in the forfeit of any registration fees and dismissal from the community.

CONFLICT OF INTEREST

Immunize Oregon, presenters, and funding agencies treat potential or perceived conflicts of interest very seriously. All potential conflicts will be disclosed by presenters and strict limitations exist on any non-educational activities or materials comingling with the clinical education being provided.

Immunize Oregon is a non-profit network and its participants are uncompensated volunteers or are involved in the coalition as part of their professional roles with various agencies. The coalition is dedicated to current clinical evidence and does not promote or recommend any brand or product. Specific brand or product names will be discussed when it is of educational value. Donations are not accepted by Immunize Oregon and no product is sold as part of coalition events. Expenses for events are covered through a combination of grant funding, in-kind contributions from our Immunize Oregon partners, registration fees, and solicited industry or charitable financial support.

Our financial supporters have no planning or curriculum involvement and no support was accepted with any stipulation or condition. Any surplus funds, after all expenses, honoraria, and invoices have been paid, will be used to support Immunize Oregon mini-grants or donated to the Randall Children's Hospital at Legacy Emanuel Medical Center.

TERMS AND CONDITIONS

PARTICIPANT REGISTRATION REQUIREMENTS

- 1.1 Access. Your registration entitles you to access to the Virtual Community for which you have registered. Any and all other costs associated with your membership shall be borne solely by you, and Virtual Community shall have no liability for such costs.
- 1.2 Use of Likeness. By participating in the Virtual Community you acknowledge and agree to grant Immunize Oregon the right at the Virtual Community to record, film, live stream, photograph, or capture your likeness in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise disseminate, in perpetuity, such media without any further approval from you. This grant to Virtual Community includes, but is not limited to, the right to edit such media, and the right to use the media alone or together with other information.
- 1.3 Virtual Event Content. You acknowledge and agree that Virtual Community, in its sole discretion, reserves the right to change any and all aspects of the Virtual Community, including but not limited to, the Virtual Community name, themes, content, program, speakers, performers, hosts, moderators, venue, and event time. Virtual Community content shall be recorded by Immunize Oregon.
- 1.4 Fees and Registration Payment. The payment of the applicable fee for the Virtual Community is due upon registration. If such payment is insufficient or declined for any reason, Immunize Oregon may refuse to allow you to access the Virtual Community and shall have no liability in that regard.
- 1.5 Registration Confirmation. Once you have completed your registration, you will receive your registration confirmation by email. Please ensure that your valid email is entered correctly on the registration form. Be sure to check your junk email box too in case any of your Virtual Community email(s) are caught by spam filters.

PROHIBITED CONDUCT

- 2.1 Limitations on Use. By registering for an Immunize Oregon Virtual Community Platform, you agree not to sell, trade, transfer, or share your complimentary access link and/or code, unless such transfer is granted by the Immunize Oregon Operations Team. If Immunize Oregon determines that you have violated this policy, the Operations team may cancel your access, retain any payments made by you, and restrict further participation in Virtual Community.
- 2.2 Disruptive Conduct. You may not defame, stalk, bully, abuse, harass, threaten, impersonate or intimidate people or entities You acknowledge and agree that Immunize Oregon reserves the right to remove you from the Virtual Community if the Operations Team, in its sole discretion, determines that your participation or behavior creates a disruption or hinders the Virtual Community or the enjoyment of the Virtual Community content by other members.
- 2.3 Recording, Live Streaming, and Videotaping. Members may not record any audio or video of sessions hosted by Immunize Oregon.
- 2.4 Prospective Members. In addition to the requirements and prohibitions outlined in this Section 2, Immunize Oregon may also exclude any prospective member from registering for or participating in any Virtual Community activity, at Immunize Oregon's sole discretion.

CANCELLATION AND QUALITY ASSURANCE

- 3.1 Feedback and Evaluation. Immunize Oregon strives to provide you with the most productive and effective educational experience possible. If after completing an event session or you feel there is some way we can improve, please provide us in writing with your comments on the evaluation provided throughout the Virtual Community and immediately following. We will evaluate individual complaints in the context of collective comments from the Virtual Community. As speakers are confirmed months before any Virtual Event, some speaker changes or topic changes may occur in the program. Immunize Oregon is not responsible for speaker changes but will work to ensure a comparable speaker is located to participate in the program.
- 3.2 All Sales are Final. Cancellations are subject to the entire Virtual Community registration fee. No payments will be refunded or refundable. Please note that if you do not cancel and do not access the Virtual Community, you are still responsible for payment. In no event shall Immunize Oregon be obligated to refund all or a portion of the registration fee.
- 3.3 If Immunize Oregon is prevented from carrying out its obligations as it pertains to the Virtual Community as a result of any cause beyond its control, or such Virtual Community cannot be conducted because of a software or issue with the hosting platform or due to acts of God, strikes, labor disputes, government requisitions, restrictions or war or apparent act of war, terrorism, disaster, civil disorder, epidemic or pandemic, curtailment or restriction on transportation facilities, or any other comparable calamity, casualty or condition (collectively a "Force Majeure") Immunize Oregon shall have the right to immediately terminate the affected Virtual Community without liability and shall be relieved of its obligations to Registered Member. If you would like to opt out of any of these benefits, a link is provided in each email to provide the ability to opt out.

YOUR PRIVACY IS IMPORTANT

EXHIBIT CRITERIA

- 5.1 Exhibit Booths will be assigned based on the order of application approval and agreement submission. The displays/table should be ready for viewing at least one week before the event start.
- 5.2 Preference will be given to Exhibitors providing services, products, or publications that are directly applicable to the management or provision of immunizations.
- 5.3 Immunize Oregon reserves the right to decline, prohibit or remove any exhibit that in its sole judgment conflicts with the character, objectives, and best interest of the event topics or is not suitable for the attendee audience. This reservation includes, but is not limited to, any violation of any Virtual Community code of conduct or these rules and regulations, and extends to persons, displays, prizes, materials, live or recorded videos, products, and conduct.
- 5.4 For-profit organizations will receive invoice requests for the agreed-upon exhibit fee to be paid in full before accessing the Exhibitor Portal
- 5.5 Exhibit Display. setup will be available upon application approval and submission of all required items. Displays/tables should be ready for viewing at least one week in advance of event kick-off
- 5.6 Noisy or unsightly work in any exhibitor area is prohibited. Immunize Oregon and the HPV
 Prevention Alliance organizers reserve the right to alter these terms as needed to ensure smooth
 conference operations.

REGISTRATION AGREEMENT
